

**Senate Order for Entity Contracts Listing relating to the period 1 JULY 2017 – 30 JUNE 2018**

**Senate Order**

Pursuant to the Senate Order for entity contracts the following table sets out contracts entered into by Northern Australia Infrastructure Facility (NAIF) which provide for a consideration to the value of A\$100,000 or more (GST inclusive) and which:

- (a) have not been fully performed as at 30 June 2018, or
- (b) which have been entered into during the 12 months prior to 30 June 2018.
